# TERMS OF SERVICE : STONE SEARCH (ALFRESCO SOLUTIONS PRIVATE LIMITED)

#### THE FOLLOWING AGREEMENT DESCRIBES THE TERMS OF SERVICE UPON WHICH STONE SEARCH (ALFRESCO SOLUTIONS PRIVATE LIMITED) OFFERS YOU ACCESS TO AND USAGE OF THE PLATFORM AND OTHER RELATED SERVICES.

#### TERMINATION

# **EFFECTS OF TERMINATION**

Upon expiration or earlier termination of your Account or rights to use a service, for any reason:
